

## TUITION AND FEES FOR 2011/2012

### 1. RATES

#### Grades Pre-K through Grade 8

**\*ARCHDIOCESE OF WASHINGTON (ADW) RATE:** To be considered for an ADW tuition rate, a family must be registered in an Archdiocesan parish for a minimum of one year prior to school registration. It is expected that those families who claim the ADW rate will attend Mass regularly, participate in parish ministries and activities, and contribute financially to the support of an Archdiocesan Parish. In addition, a letter must be furnished to OLV from the pastor of the ADW parish indicating that the family is in good standing and meets the requirements stated. If these criteria are not met, families will be expected to pay the full tuition rate.

2. **TUITION DEPOSIT:** A non-refundable deposit of \$1,000 per child is required for all students new to OLV. For students already attending OLV, a \$500 non-refundable deposit is needed to re-register. This fee will be paid directly to Our Lady of Victory School at the time the Tuition Policy Statement and Agreement is due.
3. **TUITION BALANCE PAYMENT SCHEDULE:** Three methods of payment are available for the tuition balance. These are the only authorized payment plans:
  - a. **Annual Payment:** Under this plan, the balance of tuition for the entire 2011/2012 academic year is due in full, on or before June 10, 2011 to Our Lady of Victory School
  - b. **Semi-Annual Payments:** Under this plan, one-half of the 2011/2012 academic year tuition is due June 10, 2011 and the second half due by October 10, 2011 to Our Lady of Victory School
  - c. **Monthly Payments:** Under this plan, 2011/2012 academic year tuition shall be made in installments directly to Our Lady of Victory School on the 10th of each month. Two payment plans are available:
    - (1) nine monthly payments from June 2011 - February 2012
    - (2) twelve monthly payments from June 2011 - May 2012

4. NOTES

- a. TUITION PAYMENTS: All tuition payments and school fees are non-refundable.
  - b. PROMPT PAYMENTS: Since the financial obligations of the school are heavy and continuous, families must cooperate in making payments promptly.
  - c. THE SCHOOL RESERVES THE RIGHT to cancel the registration of any student whose family fails to satisfactorily meet tuition payments or other fees (if any) at an Archdiocesan school during the preceding semester or in such cases to require full tuition payment in advance of registration acceptance.
  - d. THE SCHOOL RESERVES THE RIGHT to withhold a student's school record when the family fails to satisfactorily meet tuition payments or other school fees in a timely manner.
  - e. EARLY WITHDRAWAL: Parents who withdraw their child/children for any reason at any time after June 1, 2011 will be responsible for the full financial obligation for the entire academic year.
  - f. FUNDRAISING REQUIREMENT: All OLV School families are required to contribute \$600 to the School or contribute a minimum of 30 hours of volunteer service towards the fund raising activities. Families may choose a combination of volunteer hours and financial contributions. Any families with an outstanding balance at the end of the school year will be billed \$20 per hour.
5. HOME AND SCHOOL ASSOCIATION FEE: \$150 per family is due in full the first week of school (payable to the OLV Development Fund) or may be combined with tuition payment schedule. This fee helps to defray costs of HSA activities (Sock Hop, Breakfast with Santa, etc). As part of this fee, each school family will receive one copy of the OLV School yearbook.
6. BOOK AND MATERIALS FEES: \$325 per child, nursery through grade 8. Payment is due in full the first week of school.
